This fund will help the Grand Island Community Foundation enhance the quality of life for youth in the community, and allow children to engage in activities or programs outside of the standard school curricula and programming.

## Eligibility:

- Youth kindergarten through 12th grade
- Youth participation fees for activities or programs such as art, dance, recreation, athletics, etc. (Exclusions: school sponsored clubs, travel expenses, camps, memberships, equipment and season passes)
- Youth who qualify for the National School Lunch Program (School verification form is required and must be in English)
- Youth enrolled in a structured Grand Island community activity or program as approved by the Grand Island Community Foundation board

## Requirements:

- Request for assistance must be submitted on the approved form
- Attach a copy of the completed registration form for the activity or program
- Attach a copy of the National School Lunch Program verification form (in English)
- One scholarship (maximum of \$100) per youth per year
- Applications are due at least 4 weeks prior to the deadline for financial assistance when possible. The Grand Island Community Foundation will make every effort to process requests within 14 days.
