Commemorative Gifts

Commemorative gifts are a simple, special way to honor the memory of a loved one or pay tribute to friends and family members special occasions. These gifts impact the community by providing for a variety of needs ranging from civic enrichment to the arts.

How it Works

Donors who would like to make a commemorative gift have the following options:

- Establish a new fund
- Direct gifts to an existing fund
- Allow the recipient to choose the charity of his or her choice.

Charitable Gift Certificates

Give a gift to someone you care about by presenting them with a charitable “gift” certificate and let them choose their favorite charity to receive the gift. Tell us who you would like to honor, how much you would like to give, and where to send the gift certificate. We will work with the recipient to make a donation to his/her favorite charity.

Memorial and Honorary Gifts

Memorial Gifts

Memorial gifts are a special way to keep your loved one’s memory and legacy alive. When a loved one passes, we are faced with a painful loss and many decisions, including how to remember the impact this special person made in our lives. Contributions from multiple donors can carry on the legacy of your loved by establishing a permanent living memorial that supports their favorite charitable causes.

Memorial gifts totaling less than \$1,000 will be distributed to one field of interest chosen by the family. Once gifts total \$1,000 or more, a named memorial account will be opened. Memorial gifts totaling \$1,000 to \$4,999 will be used for discretionary grant-making with the family serving as advisors until the funds are fully expended. With memorial gifts totaling \$5,000 or more, a permanent endowment may be established in the name of the deceased.

Honorary Gifts

Honorary gifts celebrate loved ones while the honoree is still able to see the impact in the community. Donors make a donation to GGICF in honor of a loved one or friend as a birthday, wedding, graduation, anniversary or retirement gift. Funds can support the recipient’s favorite charity.
